

# Restriction on use of vehicles on poll day in the general election to village councils

**AIZAWL, AUG 6 /--**State Election Commission, Mizoram has issued Notification for General Election to Village Councils, 2020 on Wednesday, according to which the poll shall take place on August 27.

Therefore, in the interest of preserving the fairness of election process and rendering the same reflection of true choice of the people, the State Election Commission, in exercise of the powers vested in it under Article 243K of the Constitution of India read with sub-rule (1) of Rule 3 of the Mizoram

(Election to Village Councils), Rules, 2014 and other powers enabling it in this behalf, hereby issues the following restrictions on the use of vehicles during Poll Day for General Election to Village Councils, 2020:-

(i) No hiring or procuring or use of vehicles by a candidate or his agent or by any other person with the consent of the candidate or his election agent for the free conveyance of the voters to and fro the polling station shall be allowed.

(ii) In their respective Village Council area, each

contesting candidate is allowed to use one vehicle for his own use on request. The Returning Officer concerned shall issue the vehicle permit as per proforma.

The State Election Commission further orders that the District Administration shall keep a close watch on the vehicles used by Candidates and persons accompanying the contesting candidates and their supporters for any possible mischief, including criminal activities like carrying of illegal arms and weapons. If any of these

vehicles, either of a contesting candidate or a private owner, is found to be involved in any such act or for carrying anti-social elements with a view to intimidating or creating terror in the minds of the voters, it should be the duty of the District Administration to impound such vehicles and not to release them till the process of election is completed. In addition, action against the owner, the occupant/occupants and the candidate who is involved in such illegal activities shall also be taken as per law. (DIPR)

# TV actor Samir Sharma found hanging in Mumbai home

**MUMBAI, AUG 6 /--**Television actor Samir Sharma, best known for his roles in *Kyunki Saas Bhi Kabhi Bahu Thi* and *Left Right Left*, was found dead in his home in suburban Malad where he lived alone, police said today.

The 44-year-old was found hanging from the fan of the kitchen on Wednesday night, police officials said. He may have been dead for two days before he was found, they said. "We have not found any suicide note at the spot. It seems to be suicide case. It is suspected that he hanged himself two days back. We have sent the body for an autopsy," Malad police station's senior inspector George Fernandes said. Sharma, who also worked in serials such as *Kahaani*, *Ghar Ghar Ki*, *Yeh Rishtey Hai Pyar Ke* and *Wo Rehne Wali Mehlon Ki*, lived in a rented flat in Chincholi Bunder locality in Malad (West).

His body was discovered by the building's watchman, who peeped through the kitchen window and saw him hanging. He then alerted members of the society who informed the police. Police rushed to the spot and took Sharma to a hospital where doctors declared him brought dead, another official said. Efforts were on to get in touch with the family of the actor, who had been living alone since February, he said. Based on primary information, an Accidental Death Report (ADR) has been registered, Fernandes said, adding that further investigations are underway. On July 27, Sharma posted his last words on Instagram with a poem on death and dreams. I built my pyre and slept on it and with my fire it was lit. And all that was me I burned in it. I killed my dream to wake up from it. Now my dream is gone, he wrote on his page. After that, he posted some photographs but no written content. His bio on Instagram reads Actor. Writer. Poet and mostly has shots of beaches and videos of him driving to scenic places. (PTI)

# Sonowal reviews projects implemented by Assam Police



**DISPUR, AUG 6 /--**With a view to making the police service delivery mechanism more prompt and responsive, all field level police officials up to police station-in-charges across the State will be provided with a fixed mobile number soon.

The mobile numbers to be issued against the posts will ensure easy access to police establishments by public. Chief Minister Sarbananda Sonowal while reviewing different projects being implemented by the Assam Police in a meeting held at his official residence at Kharghuli in the city today directed to launch this new initiative at the earliest.

Stating that police is the initial contact agency for people in distress, the chief minister stressed on making the Assam police more smart and responsive. The chief minister also directed to make wide publicity of the contact numbers so that more and more people become aware of the numbers. He at the same time also underlined the need for making more congenial working environment for police personnel in the field and made several suggestions including retiring room for police personnel at police stations. The Chief Minister also suggested to develop boarding facility for outstation police personnel at Guwahati, who visit the city for medical purposes.

DGP Bhaskarjyoti Mahanta while apprising the chief minister about the projects being undertaken by Assam Police informed that Detail Project Report for Rs. 189 crore Assam Police Academy at Dergaon is already prepared and work for implementation would start soon. He said that the Academy will be equipped with all modern amenities and best training facilities besides avenues for modern IT interfaces to make the trainees efficient enough to deal with digital crimes.

Regarding MOITRI Scheme, DGP Mahanta informed Sonowal that construction for 73 police stations were taken up in first phase, out of which 23 had already been inaugurated. In second phase 38 police stations would be taken up, he added. The DGP also briefed Sonowal about the progress of implementation of Police Swahid Memorial and PEB Transit Camp having a capacity of 1400 personnel which is under construction at Khanapara in Guwahati.

During the meeting, the chief minister also reviewed the progress of implementation of Swahid Smark Kshetra, which will come up at West Boragoan in Guwahati. Commissioner of Public Works Department Raj Chakraborty apprised the Chief Minister about the initial activities being undertaken as part of the project.

# Assam CM remembers supreme sacrifices of Alaboi Battle heroes

**DISPUR, AUG 6 /--** Assam chief minister Sarbananda Sonowal said that true to the spirit of Alaboi Battle where the Assamese soldiers belonging to different caste and creed put up a brave resistance against the Mughals, the people of Assam at present need to unite to fight against the divisive forces acting tactically against the growth and development of Assam.

Speaking at the Alaboi Memorial Day at Dadara Higher Secondary school premises at Kamrup today, chief minister Sonowal said that the Assamese soldiers in Alaboi Battle fought on August 5, 1669 despite showing victories in the beginning were killed by the Mughals. However, the battle preceded the famous battle of Saraighat in which the Assamese forces scripted convincing victory against the Mughals. He also said

that the famous battle of Alaboi sown the seeds of victory against the mighty Mughals.

Paying rich tributes to the martyrs of the Alaboi Battle, Sonowal said that the battle generated a strong sense of nationalism. It also moved by the strong desire of protecting the motherland, served a source of motivation for the great general Lachit Borphukan for retribution and ultimately tasted victory in the Saraighat Battle against the Mughals. He also said that the battle of Alaboi has various facets which can inspire people of all generations. Like the battle of Alaboi, a strong resistance need to be created against all unscrupulous elements which are trying to create deterrent against the tempo of growth and development unleashed by the government in Assam.

He also said that considering the supreme sacrifices of Assamese soldiers in the Battle of Alaboi, the State government would set up a war memorial at Kamrup as a part of the government's rich tributes to the devotion, dedication, martyrdom of the soldiers. Sonowal also thanked the representatives of different ethnicities who were present at the memorial function at Dadara which coincided with the bhumi puja of Ram Temple at Ayodhya. # 40-year old man shot dead in new Beisumpui village

**KOHIMA, AUG 6 /--**Two unknown miscreants shot dead, one person who is in his 40s on the night of August around 8:00 pm at New Beisumpui Village under Peren District.

The gruesome incident took place when the deceased was alone at his place. The deceased has been identified as Dichtenge Newme Son of Late Namdai Wangbe of New Beisumpui Village who was serving as Jugal in Power Dept. posted in the said village. The deceased was originally from Nzauna Village under Nsong EAC Headquarter. An FIR has been lodged at Athhibung Police Station and the mortal remains of the deceased was taken to Dimapur by Police team headed by Athhibung O.C for post mortem examination.
